Task Description:

Students will conduct an inquiry into the value, threats and management strategies of Australia's Great Barrier Reef.

In-class Writing Task (20 marks + 5 literacy)

Write an in class report based on the UNESCO World heritage status of the Great Barrier Reef. You will be asked to answer the following question:

“Assess the management strategies which could be used to protect the Great Barrier Reef and added the GBR to the “in danger” UNESCO World Heritage list.”

You should use subheadings structure your response.

- Location and features of the Great Barrier Reef
- UNESCO Criteria for natural properties “in danger”
- Overview of the human and natural threats and dangers to the GBR
- Management strategies which *have been used* to preserve the GBR
- Management strategies projected *to be implemented* in the future for the GBR
- *Assessment* on whether the GBR management strategies *are successful* in preserving the reef, or whether the GBR needs extra funding from UNESCO and needs to be added to the “in danger” list.
